4. Findings of fact and reasons for decision

A. Findings of fact

In Table A in Annexure 1, I have provided a summary of my findings of fact where I have invoked specific provisions under s 33 of the Act. By invoking these provisions, I have relied on material listed in part 2 above in order to arrive at my decision.

B. Reasons for decision

In Table A in Annexure 1, I have provided the reasons for my decision for each folio exempted and those reasons are derived from the findings of fact.

5. Appeal rights

National Archives undertakes careful examination of a record before making a decision to exempt any part of a record. As part of that process we may consult with other agencies which have expertise on specific national and international matters.

If you do not agree with my decision to exempt information under a provision of s 33 of the Act, you can contact a reference officer in National Archives and seek a further explanation.

If you are still not happy with the decision and within 28 days of receiving it, you can formally appeal by:

- 1) first applying to Archives for an internal reconsideration of my decision; and
- 2) if you still do not agree with the decision, you can apply to the Administrative Appeals Tribunal for a review.

Sec. 14. An alien shall not make any false statement in any application or other document under this Act or the regulations.

Sec. 20. Any person who contravenes or fails to comply with any provision of this Act shall be guilty of an offence.

Fenalty: Fifty pounds or imprisonment for three months.

The Nationality and Citizenship Act 19 3-1955 requires an applicant for naturalization to satisfy the Minister that he has an adequate knowledge of:-

- (b) the responsibilities and privileges of Australian citizenship.

An adequate knowledge of the English language is to be understood to mean that he should be able to speak and understand English sufficiently well to carry on a conversation of matters of every-day interest, and to engage in any ordinary occupation amongst English speaking people.

As the official reports show that your client is unable to comply with those requirements, the application cannot be approved at present, but it will be reconsidered if and when he revives it after he feels that his knowledge has sufficiently improved to warrant undergoing further examination.

If, in the meantime, your client desires the fee of lodged with the application to be refunded, please advise accordingly.

During the course of enquiries as directed in your memorandum, reference 108/1/31 of 25th September, 1953, the abovenamed was interviewed by officers of this Department on 22nd October, 1953, and 8th December, 1953, relative to his compliance with the Aliens Act, and on 3rd November, 1953, a letter was forwarded to him, directing his compliance with the Act.

A copy of a statement given by Kotso on 8th December, 1953, is now attached.

Koco Afes Kotso, Albanian, born 1st August, 1909, arrived in Australia on 7th February, 1949 and on 21st April, 1950 was convicted in the Supreme Court Perth, on a charge of assault occasioning bodily harm, and sentenced to imprisonment for one month. Local Police when interviewed, reported unfavourably on the character of this Alien. It is recommended that prosecution for failing to notify change of employment under Section 10, Aliens Act 1947 proceed, and for consideration to be extended to prosecute under Regulation 18, for being in possession of a Certificate of Registration of an Alien which does not relate to him. Final paragraph of the Statement relates to this.

The Certificate concerned has been impounded, and is held at this Branch pending your considerations.


