

I interviewed this airman today and he informed me that he had a medical board on the 4th October, 1943 and categorised P.U.A.1,2, and 3 Fit Grade II.

- 2. He merely called at this Headquarters to enquire if his disposal could be expedited as it is some time since he had the Board and no action has apparently yet been taken to post him under the provisions of A.M.O.A.883/43.
- 3. He is suffering from Chronic Bronchitis. Prior to enlistment in the R.A.A.F. he had applied for service with the army and was rejected on account of foot trouble.
- 4. At the time of his enlistment in the R.A.A.F. he disclosed to the doctor at No.5. Recruiting Centre that he was troubled with Bronchitis. However, he was enlisted and during his training he had a bronchial attack, and was in the Station Sick Quarters, Ballarat. He was discharged from sick quarters, completed his training, never given a medical board and then posted to the United Kingdom.
- 5. He got up to the O.T.U. stage and when about to complete the O.T.U. owing to persistent coughing his Pilot persuaded him to see the Unit M.O. hence the medical board being arranged.
- 6. I explained the general terms of our disposal policy to Sgt. Weeks and he expressed a strong desire for repatriation. He is an extremely good type of airman and I should think very genuinely disappointed at being taken out of aircrew.

- 2. This file, although marked out to this section on 21.10.43., has only reached me today.
- 3. We have no Board proceedings, but the Officer Commanding, R.A.F. Hospital, Cosford, confirms WEEKS' statement of diagnosis and medical category.
- 4. In view of the long delay, and the diagnosis, and the onset of cold weather, I recommend repatriation and that action to expedite repatriation be taken as soon as possible.
- 5. If necessary, he could be repatriated forthwith "for health reasons", under para 22, appendix ii of the E.A.T.S. agreement, dated 31.3.43.


