SUBJECT:- ARRIVAL OF VIETNAMESE REFUGEES IN DARWIN ON 18 DECEMBER, 1976.

I wish to advise that at 3.15pm. 18 December, 1976 information was received from Mr. ANGEL of the Marine Operations Centre, Canberra, that a 'malay type fishing boat is 1 mile off North West Channel Rock in Darwin Harbour. Appears to be Asian refugees.'

- 2. Reporting member was advised by Communications Section, Darwin Station at approximately 3.30pm. 18 December, 1976 and as a result attended with Constable VANDERHAAR at the Stokes Hill Wharf at 4.10pm.
- There I observed a wooden, sixteen metre vessel bearing identification P.K. 504, anchored about 75 metres east of the Stokes Hill Wharf. Customs, Quarantine and Animal Industries officials were in attendance. Mr. LIVERIS of the Department of Immigration and Ethnic Affairs was contacted. It was ascertained that there were fifty-six men, women and children on board.
- The following note, printed in block letters was handed to Customs officials who boarded the boat. "PLEASE HELP WE US FOR FREEDONG. WE LIVE IN SOUTH VIETNAM. DONT LIVE WITH VIETNAM COMMUNISE FROM NHA-TRANG OF SOUTH VIETNAM. WE GONE TO AUSTRALIA.

 PLEASE AUSTRALIA GOVERNMENT HELP US LIVE IN AUSTRALIA.

 THERE ARE 56 PERSON IN THE BOAD.

 18 MANS, 10 WOMANS, 14 BOYS, 14 GIRLS.

 THERE ARE TEN FAMILLYS.

 WE SHALL KEEP AUSTRALIA LAW, WILL GOODMAN."
- 5. When Customs and Quarantine officials had completed their initial inspection of the boat and persons on board, the boat was moved to the wharf where it tied up and persons disembarked. The boat was then moved to a point near its original position and tied to a buoy.

Full details of persons on board were then obtained. The attached list sets out the family groups, name, position in the family, age, sex and occupation. There were no serious medical problems apparent, but I am informed that eight persons, mostly children are presently being treated for scabies.

- 7. It was ascertained that these persons left NHA-TRANG in South Vietnam on 28 October, 1976 and travelled to Darwin via Malaysia, Thailand, Singapore, Djakarta and Kupang. No person on board claimed to have relatives in Australia, but all still wished to reside in Australia.
- 8. At the present time all persons are being accommodated at the East Arm Quarantine Station, pending a full medical assessment and a decision by Immigration authorities regarding the status that will be afforded these persons. It is expected that all persons will travel per T.A.A. to Brisbane on 21 December, 1976.

> GOVERNMENT ANNOUNCES ADDITION MEASURES ON INDO-CHINESE REFUGEES

17 MAY 1978

THE GOVERNMENT REAFFIRMED ITS CONTINUING COMMITMENT TO THE RESETTLEMENT OF INDO-CHINESE REFUGEES TODAY.

"AUSTRALIA HAS A PROUD HISTORY AS A MAJOR CONTRIBUTOR IN RESETTLEMENT AND ASSISTANCE TO REFUGEES AND DISPLACED PEOPLE. WE WILL CONTINUE THIS ROLE BY HELPING TO ALLEVIATE THE PLIGHT OF PEOPLE IN OVER-CROWDED CAMPS IN MALAYSIA AND THAILAND, " THE MINISTER FOR IMMIGRATION AND ETHNIC AFFAIRS, THE HON. M.J.R. MACKELLAR, SAID IN RELEASING DETAILS OF THE GOVERNMENT'S DECISION.

"ONE OF THE FIRST ACTIONS OF THE GOVERNMENT AFTER COMING TO OFFICE IN 1975 WAS TO ARRANGE FOR THE RESETTLEMENT OF INDO-CHINESE REFUGEES. SINCE THEN WE HAVE CONTINUED TO SHOW OUR CONCERN FOR

THOSE WHO HAVE FLED VIETNAM, LAOS AND CAMBODIA." MR. MACKELLAR SAID THE GOVERNMENT'S CONCERN FOR REFUGEES HAD

BEEN REFLECTED THROUGH A NUMBER OF INITIATIVES INCLUDING: THE SETTING UP OF MACHINERY TO DESIGNATE REFUGEE SITUATIONS AND APPROPRIATE RESPONSES TO THEM,

DECISIONS TO TAKE INCREASING NUMBERS OF INDO-CHINESE IN

THE LOCATION OF IMMIGRATION TEAMS IN THAILAND AND MALAYSIA

TO ENABLE THIS TO BE ACHIEVED, THE ESTABLISHMENT OF A REFUGEE BRANCH IN THE DEPARTMENT OF IMMIGRATION AND ETHNIC AFFAIRS

THE ESTABLISHMENT OF A COMMITTEE ON THE DETERMINATION OF REFUGEE STATUS (THE DORS COMMITTEE) TO DETERMINE APPLICATIONS FROM PEOPLE IN AUSTRALIA CLAIMING REFUGEE STATUS.

"THE REFUGEE SITUATION IN THAILAND AND MALAYSIA HAS REACHED EXTREMELY SERIOUS PROPORTIONS. OVER 110,000 REFUGEES ARE CURRENTLY IN CAMPS IN THAILAND AND OVER 7,500 ARE IN CAMPS IN MR. MACKELLAR SAID.

"DURING RECENT WEEKS THE NUMBERS OF REFUGEES ARRIVING

IN SMALL BOATS OFF THE COAST OF THAILAND AND MALAYSIA HAS MORE THAN DOUBLED WITH OVER 4,000 ARRIVING IN THE PAST MONTH.

'THE CROWDED CONDITION OF THE CAMPS, THE ESCALATING NUMBERS OF PEOPLE LEAVING VIETNAM AND THE CONTINUING UNAUTHORISED ARRIVAL OF REFUGEES IN NORTHERN AUSTRALIA HAS STRESSED THE IMPORTANCE OF A CONTINUING AND BROADER INTERNATIONAL RESPONSE TO THE INDO-CHINESE REFUGEE SITUATION.

"THESE MATTERS WERE THE SUBJECT OF INTENSIVE CONSULTATIONS WITH VICE-PRESIDENT MONDALE DURING HIS RECENT VISIT TO AUSTRALIA. THE UNITED STATES HAS INDICATED A COMMITMENT TOWARDS MOVING MORE QUICKLY THOSE THEY HAVE ACCEPTED FOR ENTRY TO THEIR COUNTRY. THIS INCLUDES REFUGEES WHO ARRIVED WITHOUT AUTHORISATION IN AUSTRALIA BUT WHO HAD ALREADY BEEN ACCEPTED FOR RESETTLEMENT IN THE UNITED STATES.

"THE UNITED STATES WOULD ALSO JOIN WITH AUSTRALIA IN EFFORTS TO OBTAIN WIDER INTERNATIONAL INVOLVEMENT IN REFUGEE RESETTLEMENT. IT WAS AGREED THAT CONTINUING CONSULTATIONS ON THE REFUGEE PROBLEM WOULD TAKE PLACE. "

THE AUSTRALIAN GOVERNMENT WHICH HAD BEEN CONSTANTLY MONITORING DEVELOPMENTS. HAD NOW DECIDED ON A NUMBER OF FURTHER INITIATIVES. THESE INCLUDE:

OUR DETERMINATION TO ACTIVELY PURSUE THE ''INTERNATIONALISATION' OF THE APPROACH TO THE INDO-CHINESE SITUATION BY CONCERTED ACTION WITH THE UNITED STATES OF AMERICA AND OTHER RECEIVING COUNTRIES TO PERSUADE MORE NATIONS TO ACCEPT REFUGEES FOR

HIGH LEVEL APPROACHES TO REGIONAL GOVERNMENTS SEEKING

THEIR CO-OPERATION IN HOLDING VIETNAMESE VESSELS IN TRANSIT TO ENABLE PROCESSING OF BOAT PEOPLE IN THOSE COUNTRIES, A DECISION TO ACCEPT 9,000 INDO-CHINESE REFUGEES IN 1978/79, AN APPROACH TO THE UNITED NATIONS HIGH COMMISSION FOR

REFUGEES SEEKING GREATER INVOLVEMENT OF THAT ORGANISATION

AMONG RECEIVING COUNTRIES AND REGIONAL GOVERNMENTS.
''PROVIDED OTHER COUNTRIES ALSO PLAY THEIR PART, WE CAN ASSIST IN THE MORE RAPID RESETTLEMENT OF INDO-CHINESE REFUGEES FROM

THE CAMPS TO TRY TO REACH AUSTRALIA, " MR. MACKELLAR SAID.
"IN SAYING THIS, I WOULD STRESS THAT OUR RESPONSES TO DATE
HAVE BEEN LARGELY EFFECTIVE. ONE NEEDS ONLY TO COMPARE THE FIGURES OF OVER 4,000 BOAT PEOPLE REACHING TRANSIT CAMPS IN THAILAND AND MALAYSIA DURING THE LAST MONTH WITH THE 1,500

NEW REFUGEE TO BE FORCE FOR SOUTH-EAST ASIAT, INCREASED COASTAL SURVEILLANCE

THE GOVERNMENT HAS DECIDED THAT A TEAM OF EXPERIENCED IMMIGRATION OFFICERS WILL TRAVEL TO THE MALAYSIA-SINGAPORE AREA NEXT WEEK TO INTERVIEW AND PROCESS BOAT PEOPLE FROM INDO-CHINA APPLYING TO COME TO AUSTRALIA.

THIS WAS ANNOUNCED TODAY BY THE MINISTER FOR IMMIGRATION AND

ETHNIC AFFAIRS, MR. MACKELLAR, AND THE MINISTER FOR HEALTH, MR. HUNT. IN A JOINT STATEMENT, THE MINISTERS ALSO SAID THAT URGENT CONSIDERATION WAS BEING GIVEN TO SURVEILLANCE REQUIREMENTS ESSENTIAL TO SAFEGUARD AUSTRALIA AGAINST UNAUTHORISED ENTRY AND TO MAINTAIN THE EFFECTIVE STANDARDS OF QUARANTINE WHICH HAD PREVAILED IN AUSTRALIA.

THERE WERE THE IMPORTANT CONSIDERATIONS OF PROTECTING AUSTRALIA AGAINST THE INTRODUCTION OF DISEASES WHICH COULD THREATEN

AUSTRALIAN LIVESTOCK INDUSTRIES AND AGRICULTURE.

ANY NECESSARY CHANGES IN REQUIREMENTS FOR SURVEILLANCE AND PATROL WOULD BE CONSIDERED URGENTLY BY THE INTERDEPARTMENTAL COMMITTEE ON SURVEILLANCE.

IT WAS ESSENTIAL THAT ENTRY TO AUSTRALIA WAS CONTROLLED - BUT ANY ACTION TAKEN TO ENSURE THIS HAD TO BE LEAVENED WITH HUMANITY

AND COMPASSION FOR THE PLIGHT OF GENUINE REFUGEES.
THE MINISTERS SAID THE DESPATCH OF AN ADDITIONAL TASK-FORCE WAS TO ASSIST THE ORDERLY INTERNATIONAL PROCESSING OF REFUGEES IN THE MALAYSIA-SINGAPORE AREA AND THEREBY AVOID THE NEED FOR GENUINE

REFUGEES TO MAKE THE HAZARDOUS VOYAGE TO AUSTRALIA.

MINISTER COMMENTS ON WATERSIDER'S ACTION ON REFUGEES

THE MINISTER FOR IMMIGRATION AND ETHNIC AFFAIRS, MR. M.J.R. MACKELLAR, SAID TODAY THAT HE HAD BEEN ADVISED ABOUT A MOTION PASSED BY THE DARWIN BRANCH OF THE WATERSIDE WORKERS' FEDERATION.

THE FEDERATION HAD DECIDED TO STOP WORK FOR TWO HOURS ON EACH SHIFT TO HIGHLIGHT THE ILLEGAL ENTRY OF ALLEGED VIETNAMESE

INTO AUSTRALIA.

THE MINISTER SAID THAT HE UNDERSTOOD THE WATERSIDE WORKERS' FEDERATION WAS CONCERNED ABOUT THE ADEQUACY OF AUSTRALIAN DEFENCES AND POSSIBLE FLAWS IN THE QUARANTINE OPERATION AND THAT THE FEDERATION DID NOT BELIEVE THAT THESE IMMIGRANTS WERE REFUGEES SOME 2 1/2 YEARS AFTER THE VIETNAM WAR HAD ENDED.

MR. MACKELLAR SAID THE WATERSIDE WORKERS' FEDERATION WAS ALSO PROTESTING ABOUT THE EXTRA BURDEN ON SOCIAL SERVICES WHICH THE BOAT PEOPLE CAUSED AND THE POSSIBILITY THAT THEY WOULD COMPETE FOR

JOBS.

REFUGEES.

THE WATERSIDE WORKERS FEDERATION AT THEIR MORNING SMOKO ON TUESDAY 22ND NOVEMBER, 1977 HAD 75% OF THEIR WORKFORCE IN ATTENDANCE AND PASSED A MOTION WHICH IS SET OUT AS FOLLOWS:-

"THE DARWIN BRANCH OF THE WATERSIDE WORKERS FEDERATION WILL STOP WORK FOR TWO (2) HOURS ON EACH SHIFT TO HIGHLIGHT THE ILLEGAL ENTRY OF ALLEGED VIETNAMESE INTO AUSTRALIA. WE CONSIDER THIS ACTION NECESSARY BECAUSE OF THE FOLLOWING:-

IT CLEARLY SHOWS THE INADEQUACY OF THE AUSTRALIAN DEFENCES WHEN FOREIGN VESSELS CAN GET RIGHT INSIDE THE HARBOUR BEFORE BEING DETECTED. IT ALSO SHOWS FLAWS IN OUR QUARANTINE OPERATION WHICH ALREADY SHOWS GAPS WITH A FINDING OF A DISEASE BLUE TONGUE IN THE NORTHERN TERRITORY. WE DO NOT CONSIDER THAT THESE IMMIGRANTS ARE REFUGEES 2 1/2 YEARS AFTER THE END OF THE WAR AND SEE NO REASON WHY WE SHOULD IMPOSE AN EXTRA BURDEN ON OUR SOCIAL SERVICES WHICH HAVE BEEN CUT TO A MINIMUM BY THE FRASER GOVERNMENT BY SUCCOURING THESE ILLEGAL IMMIGRANTS WHO WILL BE SWELLING THE RANKS OF OUR EVER GROWING UNEMPLOYED. WE HAVE OUR DOUBTS AS TO THE MORAL FIBRE OF THESE IMMIGRANTS WHO COULD FINISH UP AT THE END OF A VERY LONG WAR WITH GOLD BARS AND SERVANTS. WE DEMAND THAT THE GOVERNMENT GIVE AN IMMEDIATE ANSWER ON WHAT IT IS PREPARED TO DO TO STOP THIS MOUTRAGE AND CALL ON THE PEOPLE OF DARWIN AND AUSTRALIA TO LODGE THEIR PROTESTS."

THIS INFORMATION CAME FROM MR. KEVIN MANSKI SECRETARY OF THE WATERSIDE WORKERS FEDERATION WHO SAID THAT THE TWO (2) HOURS STOP WORK ON EACH SHIFT ONLY APPLIES TODAY BUT THAT THE FEELING OF THE MEMBERS WAS THAT WHENEVER ANY OTHER VIETNAMESE BOATS ARRIVE THEY MAY STOP WORK.

THIS IS APPARENTLY A FOLLOW-UP TO A MOTION PASSES AT THEIR GENERAL MEETING ON THE 10TH NOVEMBER, 1977 AS A RESULT OF WHICH A LETTER WAS SENT TO THE MINISTER ON THE 14TH NOVEMBER, 1977. I BELIEVE THE LETTER WAS ALONG SIMILAR LINES.

The World War II-vintage minesweeper Roland . . . to bring Vietnamese refugees to Australia?

Ex-minesweeper collecting Vietnam refugees

From MICHAEL RICHARDSON

SINGAPORE, Friday. It now appears certain that an organised attempt will be made soon to ship hundreds of Vietnamese refugees to Australia and land them in Darwin.

There are also There are also indications that the refugee rescue project under way in South-East Asia includes plans to ferry additional shiploads of displaced Indo-Chinese to Australia over the next few months. few months.

The Australian High Commission in Malaysia has alerted Canberra about the activities of a World War II US minesweeper now collecting Vietnamese refugees in Malaysia and Thailand.

nd. In Kuala Lumpur, a In Kuala Lumpur, a senior official of the United Nations High Commission for Refugees (UNHCR) confirmed that the 150ft (about 46m) ocean-going minesweeper already had taken on board about 100 refugees.

gees.

He said a UNHCR officer now visiting refugee camps on the east coast of Malaysia had been told by refugees of the vessel's intended move-

vessel's intended movements.

"They informed my officer that people associated with the ship have been telling them that if they want to go to Australia they should get on board," he said.

"The Vietnamese in the camps are being told that the Australian Government has agreed to accept up to 3,000 refugees. But as far as I know, this simply is not true."

true."
The minesweeper —

called the Roland — is chartered as part of a rescue project for several thousand men, women and children who have escaped from communist Vietnam on small boats.

Most of them are being given temporary care in coastal camps in various parts of South-East Asia while the UNHCR tries to find permanent homes for them abroad.

remainent homes for them abroad.

The rescue project was organised by the World Conference on Religion and Peace (WCRP) and its Asian chapter after a meeting in Singapore last month that considered the plight of sea refugees and the slow progress in finding Western States willing to take them.

The group includes representatives of all major religions.

Organisers of the res-

major religions.
Organisers of the rescue operation are known to have substantial funds to work with. The Japanese chapter gave the equivalent of about \$A50,000.

The minesweeper Roland was well stocked with food, clothing and medical supplies when it left Singapore early this

left Singapore early this month.

The UNHCR regards the scheme as a case of "misguided philanthropy" and believes it could jeopardise the supervised international relief and re-settlement program for refugees who have left Indo-China by sea.

senior UNHCR The senior UNHCR representative in Kuala Lumpur said today the Roland was now believed to be heading for an island off the east coast of peninsular Malavsia, where 350 Vietnamese are camped.

"We have been told it will then go to southern Thailand and anchor in

international waters off the port of Songkhla, where there are about seven hundred more refu-gees," he said.
"In conjunction with third countries like the United States, France, Canada and Australia, we are processing many of these people for re-settlement. But it takes time.

"If a ship suddenly appears offering an immediate passage to mediate passage to Australia, it's likely to attract a big response.
"Based on

"Based on our information, the mine-sweeper should be back in the Singapore area in

about a week.
"It will then either take on more fuel and supplies before sailing to supplies before sailing to Darwin, or it will transfer those on board to a larger ship, which will ferry them to Australia, while it returns to the South China Sea to try and pick up more refugees."

He said the UNHCR was concerned at the effects of the WCRP

effects of the WCRP scheme.

Some of the refugees already taken on board the Roland would have been approved for entry to the United States, Canada and Belgium—had they waited.

They were now going to Australia, where they had no guarantee of acceptance and which

The UNHCR representative added that it was very unlikely they, or any other refugees ferried out from coastal camps by small boats to the minesweeper, would be permitted to land again in South-East Asia, where Governments were reluctant to accept any more I n do-Chinese without guarantees of resettlement abroad. ment abroad.

SUBJECT: ARRIVAL OF VIETNAMESE REFUGEES IN DARWIN ON 18 DECEMBER, 1976.

I wish to advise that at 3.15pm. 18 December, 1976 information was received from Mr. ANGEL of the Marine Operations Centre, Canberra, that a 'malay type fishing boat is 1 mile off North West Channel Rock in Darwin Harbour. Appears to be Asian refugees.'

- 2. Reporting member was advised by Communications Section, Darwin Station at approximately 3.30pm. 18 December, 1976 and as a result attended with Constable VANDERHAAR at the Stokes Hill Wharf at 4.10pm.
- There I observed a wooden, sixteen metre vessel bearing identification P.K. 504, anchored about 75 metres east of the Stokes Hill Wharf. Customs, Quarantine and Animal Industries officials were in attendance. Mr. LIVERIS of the Department of Immigration and Ethnic Affairs was contacted. It was ascertained that there were fifty-six men, women and children on board.
- 4. The following note, printed in block letters was handed to Customs officials who boarded the boat. "PLEASE HELP WE US FOR FREEDONG. WE LIVE IN SOUTH VIETNAM. DONT LIVE WITH VIETNAM COMMUNISE FROM NHA-TRANG OF SOUTH VIETNAM. WE GONE TO AUSTRALIA.

 PLEASE AUSTRALIA GOVERNMENT HELP US LIVE IN AUSTRALIA.

 THERE ARE 56 PERSON IN THE BOAD.

 18 MANS, 10 WOMANS, 14 BOYS, 14 GIRLS.

 THERE ARE TEN FAMILLYS.

 WE SHALL KEEP AUSTRALIA LAW, WILL GOODMAN."
- 5. When Customs and Quarantine officials had completed their initial inspection of the boat and persons on board, the boat was moved to the wharf where it tied up and persons disembarked. The boat was then moved to a point near its original position and tied to a buoy.

Full details of persons on board were then obtained. The attached list sets out the family groups, name, position in the family, age, sex and occupation. There were no serious medical problems apparent, but I am informed that eight persons, mostly children are presently being treated for scabies.

- 7. It was ascertained that these persons left NHA-TRANG in South Vietnam on 28 October, 1976 and travelled to Darwin via Malaysia, Thailand, Singapore, Djakarta and Kupang. No person on board claimed to have relatives in Australia, but all still wished to reside in Australia.
- 8. At the present time all persons are being accommodated at the East Arm Quarantine Station, pending a full medical assessment and a decision by Immigration authorities regarding the status that will be afforded these persons. It is expected that all persons will travel per T.A.A. to Brisbane on 21 December, 1976.

VIETNAMESE SHIP, DARWIN

Further information as at 2 p.m. Darwin time from Customs and other officials indicates the following in relation to the Vietnamese ship, registration number 1071 (unnamed) which arrived in Darwin this morning.

The vessel was registered in Vung Tau, Vietnam and had a complement of 50 refugees who have indicated that they have "come for freedom" to Australia. The complement is made up of a Captain and three crew, all male, 14 adult males, 13 adult females and 19 children. They left Vung Tau on 17 September, thence via Singapore, Djakarta, Bali and Koepang, leaving Koepang on 5 November and arriving in Darwin this morning. The Captain and Master of the vessel is the owner - Huynh Ngoc, formerly of the Vietnamese Navy.

Customs report that they virtually have no possessions, no prohibitive imports but there is an amount of gold on board, not yet assessed in value and a small amount of US dollars.

They were disembarked at 12.30 at Stokes Hill Wharf and were taken by bus to the quarantine reserve at East Arm. The Health authorities indicate there has been some evidence of scabies and further quarantine, Immigration and Customs formalities will be completed this afternoon at East Arm.

The Red Cross are assisting with clothing and the Emergency Services group are available to assist with any particular further accommodation needs.

REFUGEES -

50 persons arrived in Darwin on board a vessel "No. 1071" registered in Vungtau, Vietnam. The 50 comprised the captain and 3 crew (all male) plus 14 adult male, 13 adult female and 19 children.

All persons on board are Vietnamese Nationals.

Customs and Immigration have established that the vessel left Vungtau on 17 September and travelled to Darwin via Singapore, Djakarta, Bali and Koopang, leaving Koopang on 5 November and arriving in Darwin today.

The vessel is 15 foot long.

The captain/master/owner is Huynh Ngoc who is formerly of the Vietnamese Navy.

Customs report that there are virtually no possessions on the ship and no prohibited imports. There is an unassessed amount of gold and a small amount of \$US. Customs are looking at the gold question.

The objective of those on board seems to be political asylum and they state "they've come for freedom".

This seems to make the matter solidly one for Foreign Affairs.

Quarantine and Customs are handling the matter at the moment and it is assumed that Foreign Affairs do not have a man here now, but will get one here soon.

Mr. O'Brien will be advising the Minister for the Northern Territory shortly.

Other information is that the boat's complement disembarked at 12.30 and arrived at the Quarantine Reserve East Arm at approx. 1.15 p.m. where they are still stationed.

The health report is that some of the complement appear to have scabies, but that is only an initial report.

Red Cross have been asked to assist as necessary with clothing and tent accommodation, etc. and the Emergency Services Organisation have been asked to stand by for additional requirements.

Approval to land was given under section 36 of the Immigration Act by Mr. Liveris who is the Officer in Charge of Immigration in Darwin.

Regarding surveillance of the vessel, it is understood that J.I.O. had the vessel under surveillance, it was signted off Point Blaze near the mouth of the Daly River by a R.A.A.F. aircraft and was lost until it entered Darwin Harbour.

I understand that the vessel entered Darwin Harbour flying a white flag from the stern and it was presumed from this before veritication that the complement were seeking political assylum.
