- A widow of a deceased member who is also a mother of a deceased member or members will receive one badge only with a star on account of each deceased son or daughter, as well as a star on account of the deceased husband.
- If a mother of a deceased member has already received a badge in respect of a son who died on active service, she will not be entitled to a second badge in respect of a son who died whilst serving in the Merchant Service. She will, however, be entitled to a star on his account.
