CERTIFICATE OF MEDICAL EXAMINATION.

I HAVE examined the above-named person, and find that he does not present any of the following conditions, viz. :-

Mother and Father who were in bed got up and wanted to get out but they were roughly handled by the two.men. I then went for the police. As I did so the accused ran away because civilians were about to arrive. I brought the Police here then and they examined the door. They went away and brought back the accused whom I now identity. There was a bottle of Malaga not quite full in the shelf. After accused went the bottle of Malaga was gone.

The men remained in the house about I hour. I recognised the accused in the yard. They were then in the light. I was frightened after the affair when identifying the accused and very nervous. There was much conversation here while they were here. They was a strong light in the room. Accused first came here at 8.30pm.

BY THE COURT. I know both accused well.

2nd Witness. Madame Zoe. Duhamel sworn: -

I am Mother of Mddle. A. Gourguechon.

My name in Gourguechon. My family name is Duhamel. On
29 Oct. 1918 I was in bed when my daughter was going to
bed. I heard a noise at the door. My daughter went out of
one room and I followed. When I came out I saw the accused.
outside the house. When I came out they were trying to
open the window from outside. The accused then opened the
door and entered the house. Aftery they had antered there

I was with both accused. We came to Madame's Estaminet. We left the Estaminet just before 8 pm. We went from Madam's Estaminet to the Latrines. We talked there some time and both accused were arrested and brought to the Estaminet for identification.

we never returned to Madame's Estaminet. e were at the latrines about 1 hour. I first met both accused in another Estaminet and then started home and came to Madame's Estaminet and stayed 10 minuted. We never went to any other Estaminet after leaving Madame's. We never went to out billet. We all slept together in the same billet. From the time we left the Estaminet till we were arrested. I had a few drinks that night.


