3. Stalo Cesari swear that I will well and truly serve our Sovereign Lord the King in the Australian Imperial Force from 15/7/1915 until the end of the War, and a further period of 15 months thereafter unless sooner lawfully discharged, dismissed, or removed therefrom and that I will resist His Majesty's enemies and cause His Majesty's peace to be kept and maintained; and that I will in all matters appertaining to my service, faithfully discharge my duty according to law.

CERTIFICATE OF MEDICAL EXAMINATION.

I HAVE examined the above-named person, and find that he does not present any of the following conditions, viz. :-

Scrofula ; phthisis ; syphilis ; impaired constitution ; defective intelligence ; defects of vision, voice, or hearing ; hernia ; hæmorrhoids ; varicose veins, beyond a limited extent ; marked varicocele with unusually pendent testicle ; inveterate cutaneous disease ; chronic ulcers ; traces of corporal punishment, or evidence of having been marked with the letters D. or B.C. ; contracted or deformed chest ; abnormal curvature of spine ; or any other disease or physical defect calculated to unfit him for the duties of a soldier.

He can see the required distance with either eye ; his heart and lungs are healthy ; he has the free use of his joints and limbs ; and he declares he is not subject to fits of any description.
