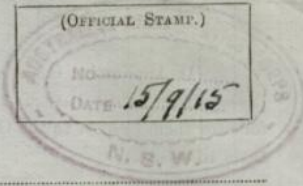

My late brother and also my late Mother, have made me their Trustees, and any information received I can forward to the other members of our family.

There has been an official photograph, No. 3362, published in the press of my brother's grave, as mentioned in your letter under reply. I am particularly anxious to obtain three copies of this photograph, before the negative is lost trace of. Will you kindly inform me to whom I can apply, and if necessary I will forward whatever cash is required to cover cost of same.

I have been shown a War Map of France, edition 4B Sheet 62cNW on a scale of 1/20000, which includes Biaches and Peronne. If you can obtain one of these for me I would like to have same and am willing to pay whatever cost is necessary. In your letter under reply you mention that the grave is situated near the above villages, but if you have the grave registration and map reference I would like to know these in order that I may mark them on map.

It is my intention on some future date to proceed to France to see that my brother's remains are properly cared for.
