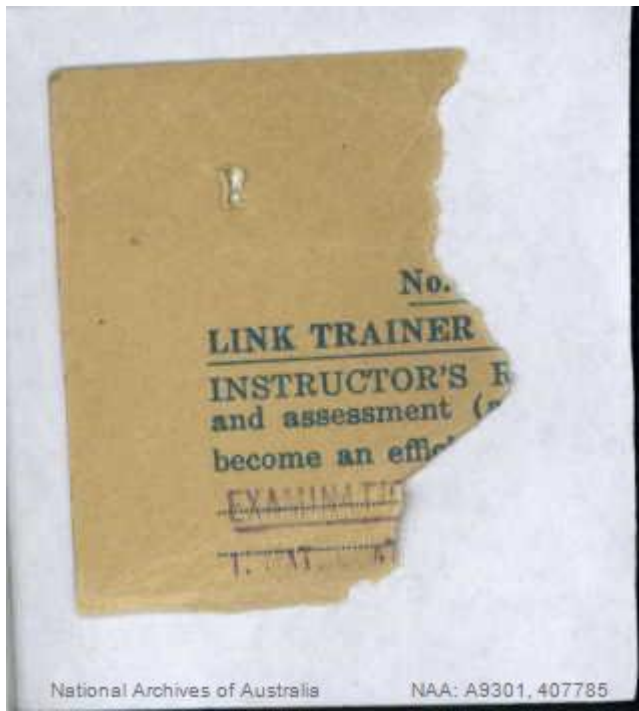

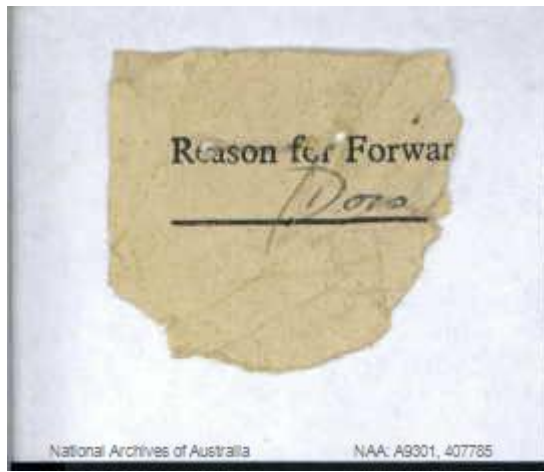

CERTIFICATE OF MEDICAL EXAMINATION.

I HAVE examined the above-named recruit, and find that he does not present any of the following conditions, viz. :-
